### PRESIDENT'S MESSAGE

Welcome to the fall edition of the *Suri Network News*, wrap-up of the recent Suri Network Summer Symposium, and update on Board activities.

I would like to thank everyone who contributed to and participated in making this year's Summer Symposium and fleece show competition an outstanding success. The Suri Network annual symposium is the highlight of the summer and an opportunity to truly feel excitement and pride in being a Suri breeder. While this year's symposium was moved to an area with a greater concentration of Suri breeders than in the past, we gained only a small additional number of attendees while greatly increasing symposium costs. We've surveyed both the attendees and non-attendees of this year's symposium and the results show that cost, location and time of year are important considerations for determining attendance. The Board will be studying the structure and venue of the annual symposium and how to continue to bring important educational opportunities to the membership within a more reasonable cost to our budget.

The Suri Network Board has many important agenda items in front of us and we are following the Suri Network Long Range Plan to accomplish tasks that will result in increased benefits for all members. Certainly marketing our Suri alpacas, Suri fiber and products is at the top of everyone's list of importance. Our recent partnership with Openherd has given all Suri Network members an opportunity to showcase their Suris and products in one venue and we will be promoting the Suri Network web site as the source of everything Suri to drive buyers to your farm. We've seen market dynamics move from a strong sellers market to a very competitive buyers market where we all have to work harder to assure ongoing sales and offering quality has become more important than ever.

As we work together to develop and gain recognition for world class Suri breeding stock and fiber, we are seeing the basis for recognizing high quality Suris move from show results alone, which currently have high marketing value, to a focus on objective data, calculated EPDs and classification information. A shift of this magnitude doesn't happen overnight and depends on the full understanding of the breeder and the

education of the buyer. While some may remain content to rely solely on the quick review of a show judge to value alpacas, those who begin now to prepare for the evolving market of the future will take time to focus on gathering objective data and will then be better positioned for marketing success. Using the Suri Breed Standard as a guide we can incrementally develop a Suri Herd Improvement Plan, SHIP, which will increase available EPD data resulting in better informed breeding decisions and increased quality in the North American Suri herd. While numerous articles and symposium presentations have addressed various components of Suri herd improvement and some pilot farm classifications have taken place, you will receive more specific information very soon for your review as we solicit input from all members to gauge understanding and support for the components of the SHIP initiative. The Suri Network Board is currently in discussion with the ARI Board regarding the possible inclusion of additional Suri traits within the ARI EPD data base. The open availability of comprehensive EPD data is the backbone of other successful livestock breeds and another step toward Suris becoming a true livestock industry.

Our Board of Trustees election results were announced at the symposium. Tim Sheets was newly elected to the Board and I was re-elected. A big thank you to our outgoing Board member, Jack Hanna, who served as Treasurer for the last 2 years and coordinated the 2011 symposium. The Board has elected officers as follows and agreed to the following assignments of primary responsibility. We are always looking for volunteers to serve in any of these areas. If you are interested in becoming involved, please contact the appropriate Board member. This is a membership organization and the more involvement we have the more we can accomplish together.

This year's theme was "Setting the Stage for Advancement" and presentations were offered by leading camelid practitioners on a variety of topics including herd health, EPDs and genetics, Suri fiber and marketing. A special thank you to outgoing board member Jack Hanna for putting together this year's outstanding event.

A major benefit of attending the Suri Symposium each year is the opportunity to network and enjoy the camaraderie of Suri breeders from across the country. Thursday evening, Ray and Maria Rodriguez, Leraso Farm Alpacas, hosted a gourmet BBQ for everyone that was a wonderful kick-off for the symposium. A hearty "Thank You!" to Ray & Maria. The Thursday pre-conference clinics included a Neonatal clinic presented by Dr. Toni Cotton; Parasitology with Fecal Analysis presented by Dr. Pam Walker; Suri Textiles 101 presented by Gwen Perkins and Understanding Suri Fleece & Fiber presented by Ann Mayes. Hands-on Herd Classification took place at Leraso Farm, led by Susan Tellez and Dick Walker who were assisted by Sharon Loner and Diana Timmerman.

Several featured speakers presented a variety of topics essential for the improvement and care of Suri herds. Dr. Ahmed Tibary spoke on "What's New in Alpaca Medicine & Reproduction." Dr. Tibary is a professor at Washington State University Veterinary Medicine and his research interests include large animal reproduction, Bovine, Camelid and Equine.

Dr. Pam Walker is a Board Certified Large Animal Internist and she presented the "Top 10 Most Common Problems in Camelids." Dr. Clint Schwab presented material on EPDs and Genetics. Dr. Schwab is Director of Genetic & Technical Services at the National Swine Registry.

Dr. Juan Pablo Gutierrez from Madrid, Spain presented his EPD research from data gathered in Peru. He is a professor with the Departamento de Production Animal Universidad Complutense de Madrid, Spain, specializing in Animal Genetics.

Nick Hahn updated the membership on the activities of Alpaca United. A panel discussion was held on marketing Suri products and participants included Ann Mayes, Alpcas D'Auxvasse; Dick Walker, SuperSuris and Beth Brown, Odelia Farms.

The Suri Herd Improvement Program (SHIP) was discussed by Kathleen Cullen, Dick Walker and Susan Tellez; and moderated by Brett Kaysen. Another discussion on breeding strategies was also moderated by Brett Kaysen.

Hazen Reed of BreedWorks presented information on Social Network Marketing that was of great interest to those in attendance.

Committee updates were given by Kathy Gilliland for the Product Development Committee; and by Joyce

White for the SN Youth Program. A captivating video, "Jordan's Story," was shown by Joyce which told the story of a young girl who became involved with Suris through 4-H.
